

Conditions for issuing Malaysia electronic visa

E-VISA is an easy-to-use online platform that allows foreign nationals to apply for an electronic visa to visit Malaysia, all from the comfort of your home. Designed to be convenient and efficient, it ensures a smooth and professional application process, making your journey to Malaysia hassle-free.

E-visa Options

- **VTR (Visa Without Reference)**
- **VDR (Visa With Reference)**

VTR (Visa Without Reference)

Required for individuals seeking to enter the country for the purpose of a social visit. This visa is typically issued for Touristic purpose.

Extension: An Extension may be given on Special consideration e.g. due to illness, accident, war in home country etc. The visitor must furnish evidence, and also present a confirmed return ticket to their home country or third country. (Extension Form: [Form IMM.55](#))

○ Required Documents

- ✓ Passport sized studio photo (White background)
- ✓ Passport bio data page with passport validity more than six (6) months from travel date to Malaysia.
- ✓ Passport page with previous passport number.
- ✓ Round trip flight ticket/ proof of journey.
- ✓ Proof of paid accommodation/hotel booking.
- ✓ Employment Letter.
- ✓ Proof of financial support.
- ✓ Birth certificate for minor applicants.
- ✓ Bank Statement and Bank maintenance letter of the last 6 months with a closing balance of **200,000 to 500,000**.

○ Payment

The Payment is required to be done in advance.

Standard/Normal e-Visa is issued within 4-6 Weeks.

Normal e-Visa Fee: 17,000 PKR

Urgent e-Visa is issued within 2-3 working days, regardless of holidays and non-working days.

Urgent e-Visa Fee: 27,000 PKR

VDR (Visa With Reference)

Required for students, individuals seeking employment, dependents, and professionals on a visit pass. Before applying for an eVISA, please ensure you have obtained your VDR approval letter.

○ Required Documents

- ✓ Visa approval letter.
- ✓ Passport bio data page with passport validity more than six (6) months from travel date to Malaysia.
- ✓ Passport page with previous passport number.
- ✓ Proof of financial support.
- ✓ Other supporting documents.

○ Payment

The Payment is required to be done in Advance.

Standard/Normal e-Visa is issued within 4-6 Weeks.

Normal e-Visa Fee: 17,000 PKR

Urgent e-Visa is issued within 2-3 working days, regardless of holidays and non-working days.

Urgent e-Visa Fee: 27,000 PKR

ABOUT E-VISA

- In case of submission of false or incomplete information or incorrect realization of payments, an electronic visa application is not accepted.
- If the attached copy of a photo page of a travel document cannot be readable or blur, the issuance of an e-visa will be rejected.
- An e-visa application is rejected or an issued visa is cancelled or a person is not allowed to enter the country in cases set forth in Article 16 of the Migration Code of the Republic of Azerbaijan. We does not bear any responsibility for rejection to issue an e-visa or ban to enter the country.
- In case of rejection to issue an electronic visa, we will send information explaining grounds for such rejection to an applicant's email address.
- In case of rejection to issue an e-visa, foreigners and stateless persons may re-apply for a visa at a relevant diplomatic representation of the Republic of Malaysia.
- No refund will be granted for payments in case of electronic visa rejection.
- An electronic visa is not attached in a passport. An e-Visa should be printed out by a foreigner or a stateless person and presented together with a travel document at a border checkpoint of the Republic of Azerbaijan.
- An electronic visa is an initial document permitting entry into and travel within the Republic of Azerbaijan. Entry may be prohibited in cases specified in the Migration Code of the Republic of Malaysia.
- The electronic visa becomes invalid if it is not used within the period of its validity.

- Foreigners and stateless persons may apply for a new electronic visa only after leaving the territory of the Republic of Malaysia.
- Foreigners and stateless persons attempting to cross the border of the Republic of Malaysia without a travel document or a visa or with invalid travel document will be returned to their country without being allowed to enter the territory of the Republic of Malaysia.
- Foreigners and stateless persons trying to cross the border with forged documents or with documents belonging to other persons will be held liable as provided for by the law.

NOTES:

- Passport should be valid for more than 6 Months.
- Visa Fee is Non-Refundable (In case Visa gets Refused).
- E-Visa is not a Sticker Visa. Electronic visas are sent to the applicant's e-mail address after it should be printed out.
- Immigration Department on the Airport has the Authority to prohibit the entry in cases specified in the Migration Code of the Republic of Azerbaijan.
- The electronic visa becomes invalid if it is not used within the period of its validity.
- The conditions regarding the issuance of electronic visas can be altered at any time without notifying the other party.
